## PRICES

The cost of services includes everything necessary for the organization of work: special equipment, radio communication, uniform, etc. - no additional expenses will be required

The implementation of auxiliary security measures, such as archway metal detectors, video surveillance systems, and access control systems, are charged separately and can only be calculated individually. The cost of armed security services is also calculated on an individual basis
